Mayor William C. Packer called the meeting to order with the following note: Adequate notice of this meeting has been provided by adopting a schedule of meetings for 2021 which was emailed to the South Jersey Times and Courier Post on January 6, 2021, faxed on January 15, 2021 and posted on the bulletin board in the Municipal Building conforming to the directives of the "Open Public Meetings Act". Adequate notice was also posted on the Borough of Woodbury Heights website (www.bwhnj.com). Adequate notice of electronic meeting was published in the South Jersey Times on April 8, 2020, and was posted on the Borough of Woodbury Heights website (www.bwhnj.com) conforming to the directives of the Governor's Executive Order 107.

Mayor Packer led everyone in the Pledge of Allegiance.

ROLL CALL: The call of roll showed the following to be present: Councilman Joseph Getsinger, Councilman Robert Morison, Councilman Harold "Hap" Pye, Councilwoman Cara Witasick, Councilman Richard Gambale and Councilman Jeffrey Pitzo. Also in attendance were Borough Solicitor Brian Lozuke, Borough Engineer Mark Brunermer, Borough Planner Tiffany Morrissey and Janet Pizzi, Clerk/Administrator.

A motion to approve the minutes of the Regular Council Meeting March 17, 2021was made by Councilman Pye and seconded by Councilman Gambale. A roll call vote in favor was unanimous. The minutes were approved.

Mayor Packer turned the meeting over to Brian Lozuke and Tiffany Morrissey for a presentation pertaining to the New Jersey Regulatory Enforcement Assistance, and Marketplace Modernization Act, which legalizes the retail and personal use of the sale of cannabis. Solicitor Lozuke stated there are (6) licenses available, and noted the only one that cannot be regulated by the Municipality is Class 6-Delivery:

Class 1 License: Cannabis Cultivator (growing cannabis)

Class 2 License: Cannabis Manufacturer (preparing and packaging)

Class 3 License
Class 4 License
Cannabis Wholesaler (selling to other wholesalers and retailers)
Cannabis Distributor (selling between cultivators/establishments)

Class 5 License Cannabis Retailer (selling to retail customers)

Class 6 License Cannabis Delivery (delivery from retailers to retail customers)

Tiffany Morrissey stated that if the Municipality opts to do nothing by August 22, 2021, then they must permit the land uses, such as cultivating, manufacturing, and distributing in any industrial zone, and they must permit retail sales in any zones that permit retail sales. The municipality cannot change regulations for 5 years. Her recommendation is to adopt an ordinance, as of now, to prohibit the land uses throughout the municipality. This will allow the municipality time to go back, make changes, and evaluate fully, once the state sets the regulations. Councilwoman Witasick asked if CBD oil is the same, and Mrs. Morrissey stated no, it is protected because it does not contain THC. Councilman Pye stated he agrees with Mrs. Morrissey's recommendation. The only license which cannot be changed is the delivery license. Councilman Morison asked the Solicitor if there any legal ramifications if the Borough makes a complete denial. Solicitor Lozuke stated there will be no legal exposure because the law allows, within a certain window, the ability to "Opt-Out" and also stated that Mrs. Morrissey's recommendation is the prudent way to proceed. Mayor Packer asked Council if there were any objections to having Mrs. Morrissey and Solicitor Lozuke draft an ordinance for Council's consideration to opt out, and upon hearing none, it was authorized.

CLERK'S REPORT: The Clerk stated that the Financial Disclosure Statements due date has been extended and advised everyone to be on the look-out for the Local Finance Notice. Mayor Packer stated that this was the Clerk's last report, and last meeting, and presented her with a Proclamation honoring her 25 years of service to the Borough of Woodbury Heights. Mayor Packer read a letter from former Mayor Robbie Conley. Former Mayor Harry Elton, members of Council, and members of the public thanked the Clerk for her years of service. Mayor Packer announced that later in the evening Shannon Elton will be appointed Acting Municipal Clerk and Vikki Holmstrom will be appointed as Temporary Administrator.

**PUBLIC PORTION:** Mayor Packer opened the public portion for questions or comments:

On behalf of the Fire Department, Charlie Crompton thanked the Mayor for supporting the fire department hoagie sale.

9/11 Committee Members Julianne Thurber and Robert Torrissi, gave a brief update on the status of the installation of the 9/11 Memorial, which will be completed in time for the 20<sup>th</sup> anniversary of 9/11. Mrs. Thurber asked why the Borough cannot give deposits to vendors and the CFO explained to her, that with certain exceptions, it is against New Jersey Purchasing Laws. Discussion ensued.

Jessica Cross, Cherry Avenue, asked about the steps to be taken to reopen the Community Center. Discussion ensued.

Hilda Ferrante, Lake Association, asked if there will be a fishing derby this year and Councilman Morison replied that, due to regulations, at this point, it is unknown.

Upon hearing no additional comments, a motion to close the public portion of the meeting was made by Councilman Pye and seconded by Councilman Gambale. All of Council agreed. Motion carried.

ENGINEERS REPORT: Mr. Brunermer provided an update on the Fordham Road Project. Mr. Brunermer stated that field work at Veterans Memorial Park is complete, and as it appears, flag poles and everything else are within the West Jersey ROW. However, over by the Christmas tree, a couple of feet of the sidewalk that wraps around the back of the tree falls within the Conrail ROW. The survey should be complete within the next few weeks.

Mayor Packer stated that he received a second complaint of ground water percolation on Park Avenue. Discussion ensued.
