

**A RESOLUTION OF THE BOROUGH OF WOODBURY HEIGHTS

BE IT FURTHER RESOLVED that all such meetings shall take place at the Borough Hall which is located at 500 Elm Avenue in the Borough of Woodbury Heights, County of Gloucester and State of New Jersey, unless notice is provided in advance of such meeting indicating that it will be held at a different location.


