

**REGULAR COUNCIL MEETING  
BOROUGH OF WOODBURY HEIGHTS  
500 ELM AVENUE, WOODBURY HEIGHTS, NJ 08097  
AUGUST 16, 2017 7:30 P.M.**

In the absence of Mayor Robbie Conley, Council President Richard Gambale called the meeting to order with the following note: Adequate notice of this meeting has been provided by adopting a schedule of meetings for 2017 which was faxed to the South Jersey Times and Courier Post on January 9, 2017 and posted on the bulletin board in the Municipal Building conforming to the directives of the "Open Public Meetings Act".

Councilman Gambale led everyone in the Pledge of Allegiance.

The call of roll showed the following to be present: Councilman Robert Yerka, Councilwoman Cara Witasick, Councilman Harold "Hap" Pye, Councilman William Packer, Councilman Eshia "Jake" Jacob and Councilman Richard Gambale. Absent was Mayor Robbie J. Conley. Also in attendance were Borough Solicitor Brian Lozuke, Borough Engineer Mark Brunermer, Vikki Holmstrom, CMFO and Janet Pizzi, Clerk/Administrator.

A motion to approve the minutes of the Regular Council Meeting July 19, 2017 was made by Councilman Pye and seconded by Councilman Packer. A roll call vote in favor was unanimous. The minutes were approved.

**PUBLIC PORTION:** Councilman Gambale opened the public portion for questions or comments.

**Bob Morison, Beech Avenue:** Mr. Morison asked for an update regarding the police department and Councilman Pye replied that there is nothing new to report.

Upon hearing no additional questions or comments, a motion to close the public portion was made by Councilman Pye and seconded by Councilman Jacob. All of Council agreed. Motion carried.

**ENGINEER'S REPORT:** Mr. Brunermer reported that the Route 45 Project and the West Jersey Avenue Phase I Projects are wrapping up. West Jersey Phase II was just surveyed last week and should go up to the DOT sometime in the beginning of September. The concrete work on Helen Avenue will be starting next Wednesday and the following Wednesday will be the asphalt work. Helen Avenue and Third Street will be complete before Gateway Regional High School opens. Councilman Packer asked about the speed humps on Helen Avenue and Mr. Brunermer replied that they will be replaced after discussion with the Police Chief, Emergency Response and the school. The DOT roadways and bike paths application is due October 6 and Mr. Brunermer requested recommendations be made at the next regular Council meeting. Mr. Brunermer reported that he reached out to the county engineers regarding the feasibility for a joint DOT application for curbs, to replace sidewalks and to install streetlights along Elm Avenue. Councilman Packer asked about the pump station project and Mr. Brunermer replied that it is complete, and the well project will go out to bid soon with an estimated start date of mid-summer 2018.

**BEST PRACTICES INVENTORY:** Mrs. Holmstrom reported the Borough's Best Practices Inventory score was 84 out of 100. No state aid was lost but we did lose 16 points due to a financial disclosure statement not being filed by a planning board member, a fixed assets program not yet in place, and due to the Borough's sick time sell back policy.

**Public Safety:** Councilman Yerka presented the Police Department Report. A copy will be filed in the Clerk's office. No Fire Department report was filed but the Deputy Chief Edgar Seibert stated that the new air packs came in yesterday and there will be a hoagie sale on Saturday.

**Water & Sewer:** Councilwoman Witasick presented the utility report and reminded everyone that the new post card bills will be out soon. The August shut offs have been postponed. The water/sewer report was presented. A copy of these reports will be on file in the Clerk's office.

**Streets & Roads:** Councilman Pye reported that the 2017 Road Program is starting. Trees are being pruned back and storm drains are clean.

**Finance & Administration:** Councilman Packer presented the finance report. A copy will be on file in the Clerk's Office. Upon the recommendation of the CFO, a motion was made by Councilman Packer and seconded by Councilman Pye to participate in the South Jersey Power Cooperative for Natural Gas Bid. A roll call vote in favor was unanimous. Motion passed.

**Recreation & Civic:** Councilman Jacob reported on a veteran's income tax credit benefit, and legislation pertaining to a maximum driving time limit for truck drivers. The Veterans Day Ceremony will be held at 11 a.m. on Veterans Day. Volunteers are needed to help with the Patriots Day Ceremony.

**Property & Environmental:** Councilman Gambale provided a property update and noted that banks are starting to sell some of the vacant properties in town.

**Bill List:** A motion to approve the bill list as presented was made by Councilman Packer and seconded by Councilman Pye. A roll call vote in favor was unanimous. The bill list was approved.

**PUBLIC PORTION:** Councilman Gambale opened the public portion for questions or comments and upon hearing none, a motion to close the public portion was made by Councilman Pye and seconded by Councilwoman Witasick. A roll call vote in favor was unanimous. Motion carried.

**ADJOURNMENT:** A motion to adjourn was made by Councilman Pye and seconded by Councilwoman Witasick. All of Council agreed. Motion carried. The meeting adjourned at 8:20 p.m.
