

ORDINANCE 1-2016

**AN ORDINANCE OF THE BOROUGH OF WOODBURY HEIGHTS
APPOINTING TAX COLLECTOR PURSUANT TO N.J.S.A. 40A:9-142**

WHEREAS, the Tax Collector, Victoria Holmstrom, was heretofore appointed to fill the unexpired term of the Tax Collector ending December 31, 2015; and

WHEREAS, N.J.S.A. 40A:9-141 provides that the Borough Council, by Ordinance, shall provide for the appointment of Municipal Tax Collector, which term shall be for a period of four (4) years pursuant to N.J.S.A. 40A:9-142.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that VICTORIA HOLMSTROM is hereby confirmed in her reappointment to the position of Borough Tax Collector for a term of four (4) years commencing January 1, 2016, through December 31, 2019; and

BE IT FURTHER ORDAINED, as follows:

A. Compensation. The Tax Collector's compensation shall be consistent with the Township Salary Ordinance.

B. Effective. The appointments recited herein shall take effect January 1, 2016, and this Ordinance shall take effect upon final adoption, publication, and as otherwise provided by law.

C. Repealer. All Ordinances or parts of Ordinances inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

D. Saved from Repeal. All Ordinances or parts of Ordinances not inconsistent with the terms and provisions of this Ordinance are hereby saved from repeal.




