

RESOLUTION 109-2016

A RESOLUTION OF THE BOROUGH OF WOODBURY HEIGHTS MAYOR AND BOROUGH COUNCIL ADOPTING THE MITIGATION PLAN FOR FOUR NEW JERSEY COUNTIES

Whereas the Mayor and Borough Council recognizes the threat that natural hazards pose to people and property within the Borough of Woodbury Heights; and

Whereas the Borough of Woodbury Heights has participated in the preparation of the Mitigation Plan for Four New Jersey Counties, a multi-jurisdictional, multi-hazard mitigation plan in accordance with the Disaster Mitigation Act of 2000; and

Whereas the Mitigation Plan for Four New Jersey Counties includes an Appendix that identifies mitigation goals, strategies, and measures specifically for the Borough of Woodbury Heights to reduce or eliminate long-term risk to people and property from the impacts of future hazard events and disasters; and

Whereas adoption by the Mayor and Borough Council demonstrates commitment to hazard mitigation and achieving the goals outlined in the Mitigation Plan for Four New Jersey Counties.

Now, therefore, in accordance with Borough Council, be it resolved by the Borough of Woodbury Heights, Gloucester County, New Jersey, that:


The Mayor and Borough Council adopts the Mitigation Plan for Four New Jersey Counties and the Borough of Woodbury Heights Appendix including authorizing the formation and duties of the Borough of Woodbury Heights Hazard Mitigation Working Group (Working Group) as follows:

The Working Group shall be convened by the Borough of Woodbury Heights Emergency Management Coordinator and will include representatives of the following departments, agencies, and organizations and other interested parties:

- a. Woodbury Heights Officials identified in the mitigation Action Plan (Section 9)

1. The Working Group shall convene to conduct plan implementation and maintenance activities as identified in the Woodbury Heights Appendix including monitoring, evaluation, and updating the Woodbury Heights Appendix and providing annual reports to the and the County of Gloucester Office of Emergency Management.

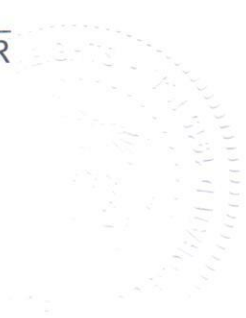
