

RESOLUTION 68-2016

RESOLUTION OF THE BOROUGH OF WOODBURY HEIGHTS AWARDING CONTRACT  
FOR THE ROUTE 45 PUMPING STATION IMPROVEMENTS PROJECT

**WHEREAS**, the Borough of Woodbury Heights heretofore advertised for the submission of bids relative to the Route 45 Pumping Station Improvements Project within the Borough; and

**WHEREAS**, bids for this public improvements project were advertised pursuant to Section 4 of P.L. 1971, c.198 (C), [N.J.S.A.40A:11-4] and publicly opened by the Township Engineer and Borough Administrator on June 3, 2016; and

**WHEREAS**, the Borough received four (4) bid proposals from the following contractors: G. Helmer Construction Company, Inc. (\$450,125.00); South State, Inc. (\$462,633.00); Mount Construction, Inc. (\$467,600.00); and Kmetz, Inc. (\$501,167.50) on June 3, 2016; and

**WHEREAS**, The Township Engineer has reviewed the four (4) bid proposals received by the Borough and has recommended the award of the Contract to G. Helmer Construction Company, Inc. in an amount not to exceed the sum of \$450,125.00 for the Route 45 Pumping Station Improvements Project as the lowest responsible bidder; and

**WHEREAS**, the bid submitted by the aforesaid G. Helmer Construction Company, Inc. is in substantial compliance with the bid instructions and specifications generated by the Borough, including submission of the requirements under N.J.S.A. 40A11-23.1b, as well as the mandatory requirements under N.J.S.A. 40A:11-23.2;

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that the Route 45 Pumping Station Improvements Project is hereby awarded to G. Helmer Construction Company, Inc. in the amount of \$450,125.00, which shall not be exceeded, subject to and conditioned upon the provisions of performance surety and further compliance with the bid documents and specifications by G. Helmer Construction Company, Inc.;

**BE IT FURTHER RESOLVED**, that the Borough Administrator is hereby authorized and directed to return all bid surety to all unsuccessful bidders forthwith after the adoption hereof.




