RESOLUTION OF THE BOROUGH OF WOODBURY HEIGHTS AWARDING CONTRACT FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT-ALLIANCE STREET ROADWAY IMPROVEMENTS PROJECT

WHEREAS, the Borough of Woodbury Heights heretofore advertised for the submission of bids relative to the Community Development Block Grant ("CDBG") Alliance Street Roadway Improvements Project for the Borough; and

WHEREAS, bids for this road project were advertised pursuant to Section 4 of P.L. 1971, c.198 (C), [N.J.S.A.40A:11-4] and publicly opened by the Township Engineer on July 8, 2020; and


WHEREAS, the Borough received one bid proposal from Landberg Construction, LLC with a Base Bid of \$33,193.47 and an Alternate No. 1 Bid of \$15,817.20 for a total bid amount of \$49,010.67 on July 8, 2020; and

WHEREAS, The Township Engineer has reviewed the bid proposal and has recommended the award of the Contract to Landberg Construction, LLC for the Community Development Block Grant ("CDBG") Alliance Street Roadway Improvements Project as the sole and lowest responsible bidder based on the following comprehensive proposal submitted by Landberg Construction, LLC, as follows: Base Bid of \$33,193.47 and an Alternate No. 1 Bid of \$15,817.20 for a total bid and project amount of \$49,010.67; and

WHEREAS, the bid submitted by the aforesaid Landberg Construction, LLC is in substantial compliance with the bid instructions and specifications generated by the Borough.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that the Community Development Block Grant ("CDBG") Alliance Street Roadway Improvements Project is hereby awarded to Landberg Construction, LLC in the following amounts which shall not be exceeded: Base Bid of \$33,193.47 and an Alternate No. 1 Bid of \$15,817.20 for a total bid and project amount of \$49,010.67, subject to and conditioned upon the provisions of performance surety and further compliance with the bid documents and specifications by Landberg Construction, LLC, including verification of funds by the Borough CFO.
