

RESOLUTION 98-2021

RESOLUTION AUTHORIZING THE PURCHASE OF A 2022 INTERNATIONAL HV507 WITH 4X2 CHASIS FOR THE DEPARTMENT OF PUBLIC WORKS UNDER THE SOURCEWELL COOPERATIVE PURCHASING AGREEMENT IN THE TOTAL AMOUNT OF \$349,878.91

WHEREAS, pursuant to N.J.S.A. 52:34-6.2(b)(3), the Borough of Woodbury Heights has previously authorized the use of Sourcewell Co-Op, previously known as NJPA, to contact with various vendors for good and services; and

WHEREAS, N.J.S.A. 52:34-6.2(b)(3) permits the award of a contract without the necessity of competitive bidding; and

WHEREAS, the Borough of Woodbury Heights is in need of a heavy duty truck; and

WHEREAS, Hunter Truck Sales and Services is an authorized International Truck vendor under Sourcewell Co-Op #060920-NVS; and

WHEREAS, the Principal Public Works Manager in conjunction with the Qualified Purchasing Agent recommends an award of a contract to Hunter Truck Sales and Service in the amount of \$349,878.91; and

WHEREAS, the Chief Financial Officer has certified funds in the amount of \$349,878.91 for the purchase of said heavy duty truck.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that the purchase of one (1) 2022 International HV507 4x2 heavy duty truck per proposal 16107 from Hunter Truck Sales and Service under Sourcewell Co-Op #060920-NVS is approved subject to the issuance of of the appropriate purchase order to Hunter Truck Sales and Service, 2320 High Hill Road, Swedesboro, NJ 08085.




CERTIFICATION OF AVAILABILITY OF FUNDS
