

RESOLUTION 113-2021

RESOLUTION AUTHORIZING THE PURCHASE OF 95-GALLON TRASH AND RECYCLING CONTAINERS UNDER THE HGAC COOPERATIVE PURCHASING AGREEMENT IN THE TOTAL AMOUNT OF \$186,172.00

WHEREAS, pursuant to N.J.S.A. 52:34-6.2(b)(3), the Borough of Woodbury Heights has authorized the use of HGAC, to contact with various vendors for good and services; and

WHEREAS, N.J.S.A. 52:34-6.2(b)(3) permits the award of a contract without the necessity of competitive bidding; and

WHEREAS, the Borough of Woodbury Heights is in need of a 95-Gallon trash and recycling containers; and

WHEREAS, Schaefer Systems International is an authorized vendor of these containers under HGAC Contract RC01-21; and

WHEREAS, the Qualified Purchasing Agent recommends an award of a contract to Schaefer Systems International, Inc in the amount of \$186,172.00; and

WHEREAS, the Chief Financial Officer has certified funds in the amount of \$186,172.00 for the purchase of said trash and recycling containers.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Woodbury Heights, that the purchase of 2,800 95-Gallon Trash and Recycling Containers per proposal 019192-2 from Schaefer Systems International, Inc under HGAC Co-Op #RC01-21 is approved subject to the issuance of the appropriate purchase order to Schaefer Systems International, Inc at 10021 Westlake Drive, Charlotte, NC 28273/

CERTIFICATION OF AVAILABILITY OF FUNDS


