RESOLUTION AUTHORIZING EXTENSION OF SHARED SERVICE AGREEMENT BY THE BOROUGH COUNCIL OF THE BOROUGH OF WOODBURY HEIGHTS FOR THE OPERATION OF A JOINT MUNICIPAL COURT WITH MANTUA TOWNSHIP; THE BOROUGH OF WENONAH; THE BOROUGH OF NATIONAL PARK; THE BOROUGH OF PITMAN; AND THE TOWNSHIP OF WEST DEPTFORD FOR LAW MUNICIPAL COURT SERVICES

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et. seq., permits municipalities and other local units to enter into Shared Services Agreements with other governmental units by adoption of a Resolution authorizing such shared services; and

WHEREAS, it is in the best interests of the Borough of Woodbury Heights and the Township of Mantua; the Borough of Pitman; the Borough of National Park; the Township of West Deptford; and the Borough of Wenonah to extend the Shared Services Agreement for a Joint Municipal Court pursuant to N.J.S.A. 2B:12-1, et. seq.; and

WHEREAS, the Borough Council of the Borough of Woodbury Heights recognize that by extending and reauthorizing the aforementioned shared service agreement with the above-referenced municipalities for a Joint Municipal Court, the particular details of which are set forth and memorialized in the Shared Services Agreement, are mutually beneficial to all participating municipalities; and

WHEREAS, such Agreements are encouraged by the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et. seq.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Woodbury Heights that the Shared Service Agreement for Joint Municipal Court services with the Township of Mantua; the Borough of Pitman; the Borough of National Park; the Township of West Deptford; and the Borough of Wenonah is hereby extended, approved and authorized for execution by the appropriate Borough Officials for municipal court, subject to the review and approval of such agreement by the Township Solicitor.

BE IT FURTHER RESOLVED, that a copy of this Resolution and Agreement shall be filed with the Commissioner of the Department of Community Affairs forthwith after the adoption hereof.
