

RESOLUTION R-31-2022

RESOLUTION AUTHORIZING AN ADDENDUM TO THE SHARED SERVICE AGREEMENT BY THE BOROUGH COUNCIL OF THE BOROUGH OF WOODBURY HEIGHTS FOR TAX COLLECTOR AND CHIEF FINANCIAL OFFICER SERVICES WITH SOUTH HARRISON TOWNSHIP

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et. seq., permits municipalities and other local units to enter into Shared Services Agreements with other governmental units by adoption of a Resolution authorizing such shared services; and

WHEREAS, it is in the best interests of the Borough of Woodbury Heights and South Harrison Township to extend the Shared Services Agreement for tax collector and chief financial officer services; and

WHEREAS, the Borough Council of the Borough of Woodbury Heights recognizes that by extending and reauthorizing the aforementioned shared service agreement with South Harrison Township for tax collector and chief financial officer services, the particular details of which are set forth and memorialized in the Shared Services Agreement, is mutually beneficial to both participating municipalities; and

WHEREAS, such Agreements are encouraged by the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et. seq.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Woodbury Heights that the Shared Service Agreement for tax collector and chief financial officer services with the South Harrison Township is hereby extended, approved and authorized for execution by the appropriate Borough Officials.

BE IT FURTHER RESOLVED, that a copy of this Resolution and Addendum shall be filed with the Commissioner of the Department of Community Affairs forthwith after the adoption hereof.

**ADDENDUM NUMBER 1 TO SHARED SERVICE AGREEMENT
BETWEEN THE BOROUGH OF WOODBURY HEIGHTS AND THE TOWNSHIP OF
SOUTH HARRISON FOR TAX COLLECTOR AND CHIEF FINANCIAL SERVICES**

This **Addendum**, made on this 19th day of January, 2022, by and between **South Harrison Township** with office located at 664 Harrisonville Road, Mullica Hill, New Jersey, 08062 (hereinafter referenced as "Township") and the **Borough of Woodbury Heights** with offices located at 500 Elm Avenue, Woodbury Heights, New Jersey, 08097 (hereinafter referenced as "Borough"), (hereinafter collectively referred to as the "Parties").

WITNESSETH:

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq, authorizes units of government to enter into such arrangements; and

WHEREAS, the Township and the Borough are parties to a Shared Services Agreement entered into in March of 2019 (hereinafter referred to as "the Agreement"), relating to Tax Collector and Chief Financial Services; and

WHEREAS, the parties have determined that it is in their best interests to continue the above referenced services; and

WHEREAS, the parties are desirous of memorializing changes to the Agreement;

NOW, THEREFORE, it is hereby agreed by and between the parties that sections of Articles B and F of the Agreement shall be amended to read as follows:

Article B, section 3: Payment from Township to Borough: The Township shall pay to the Borough a flat rate of:

All payments shall be made quarterly and due on or before the following dates:
March 15, June 15, September 15 and December 15 of each year.

Article F: Duration of Agreement: The agreement is hereby extended to March 31, 2026.

IT IS FURTHER AGREED, by and between the parties, that all other terms and conditions set forth in the Agreement and not specifically addressed in this Addendum Number 1 shall remain in full force and effect.




