## ORDINANCE 9-2022 BOROUGH OF WOODBURY HEIGHTS

# AN ORDINANCE AMENDING AND SUPPLMENTING CHAPTER 104 OF THE BOROUGH OF WOODBURY HEIGHTS CODE ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, vehicular traffic obstructing certain intersections and streets causes traffic gridlock and effectively prevents traffic to move at congested intersections; and

WHEREAS, the Borough Council believes that in order to ensure proper traffic movement and to increase safety for pedestrians and motorists alike congested intersections must be rendered as safe as is technically possible; and

WHEREAS, the Borough of Woodbury Heights desires to amend and supplement Chapter 104, Sections 104-6 and 104-30, respectively, to restrict parking along a certain portion of Alliance Street at Mantua Pike consistent with the recommendations of the Borough of Woodbury Heights Planning Board.

**NOW, THEREFORE, BE IT ORDAINED,** by the Borough Council of the Borough of Woodbury Heights, County of Gloucester, State of New Jersey, being the governing body thereof, that Chapter 104 entitled "Vehicles and Traffic", Section 104-6 is hereby amended and supplemented and specifically "Schedule I" within Section 104-30, as follows:

## SECTION 104-30 SCHEDULE I: NO PARKING SCHEDULE

Name of Street- Alliance Street

Side- Both

<u>Locations-</u> From the East side of New Jersey State Highway, Route 45, a distance of 300 feet easterly along both sides of Alliance Street

**BE IT FURTHER ORDAINED,** that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the Courts to be invalid, such adjudication shall only apply to the section, paragraph, subsection, clause or provision so adjudicated and the remainder of the Ordinance shall be deemed valid and effective.

**BE IT FURTHER ORDAINED,** that any ordinances or parts of Ordinances thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

**BE IT FURTHER ORDAINED,** that this Ordinance shall take effect upon passage and publication as provided by New Jersey law.
