## **RESOLUTION 62-2022**

## RESOLUTION AUTHRIZING PAYMENTS IN INSTALLMENTS FOR WATER AND/OR SEWER ACCOUNTS IN ACCORDANCE WITH NEW JERSEY LOCAL FINANCE NOTICE 2022-9

**WHEREAS**, LFN 2022-9 announces relief measures for residential ratepayers experiencing hardship during the COVID019 pandemic; and

WHEREAS, New Jersey Department of Community Affairs, Division of Local Government Services' Local Finance Notice (LFN) 2022-9, dated March 7, 2022 offers options for ratepayers; and

WHEREAS, the Borough of Woodbury Heights has given proper notice of the option to establish an installment plan with the Borough, for any Water and Sewer Utility arrearages accruing between March 9, 2020 and March 15, 2022, through the Tax Office; and

WHEREAS, a residential customer must make timely payments on all current charges, as well as their payments in installments for a duration of no longer than 12 months; and

WHEREAS, the residential customer has reviewed and signed the agreement outlining the parameters of said installment plan.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Woodbury Heights, that said residential customer shall make up to 12 monthly installments to include all delinquent utility charges, with said payments commencing on June 1, 2022 and concluding by May 31, 2023. It shall further be conditioned that all installments of taxes and utilities for the current years in which such agreement is made, and all subsequent taxes, utilities, assessments and other municipal liens imposed or becoming a lien thereafter shall be promptly paid when due. If payment of the aforementioned exceeds 30 days after the due date, then said agreement shall be void and the tax collector shall proceed to enforce said lien, termination of services and/or the accumulation of appropriate interest and penalties.

BE IT FURTHER RESOLVED that the tax collector is hereby authorized to accept said applications for payments in installments for the following residential customers:
