

RESOLUTION 72-2022

**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN
CONTRACT FOR TECHNOLOGY EQUIPMENT**

WHEREAS, the Borough of Woodbury Heights has a need to acquire technology equipment as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and,

WHEREAS, the Purchasing Agent/CMFO has determined and certified in writing that the value of the acquisition in addition to the existing contract with Premier Technology Solutions will exceed \$17,500; and,

WHEREAS, the anticipated term of this contract is 1 year(s) and may be extended 2 times as approved by this governing body; and

WHEREAS, Premier Technology Solutions, LLC, the current IT vendor for the Borough of Woodbury Heights has submitted a proposal dated April 19, 2022 indicating they will provide the necessary technology equipment for paperless solutions for the Clerk's Office in the amount of \$8,156.00; and

WHEREAS, Premier Technology Solutions, LLC has completed and submitted a Business Entity Disclosure Certification which certifies that Premier Technology Solutions has not made any reportable contributions to a political or candidate committee in the Borough of Woodbury Heights in the previous one year, and that the contract will prohibit Premier Technology Solutions, LLC from making any reportable contributions through the term of the contract, and

WHEREAS, the Chief Financial Officer has certified funds in the amount of \$8,156.00 for the purchase of said network security back up devices and storage


NOW THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Woodbury Heights authorizes the Mayor to enter into a contract with Premier Technology Solutions as described herein; and,

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification, the proposal of Premier Technology Solutions and the Determination of Value be placed on file with this resolution. *and,*

BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Borough Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that a notice in accordance with the Local Public Contracts Law of the State of New Jersey shall be published in the South Jersey Times.


CERTIFICATION OF AVAILABILITY OF FUNDS
