RESOLUTION OF THE BOROUGH OF WOODBURY HEIGHTS AWARDING CONTRACT FOR THE 2021 NJDOT WALNUT AVENUE ROADWAY IMPROVEMENTS PROJECT (PHASE I)

WHEREAS, the Borough of Woodbury Heights heretofore advertised for the submission of bids relative to the 2021 NJDOT Walnut Avenue Roadway Improvements Project for the Borough; and

WHEREAS, bids for this road project were advertised pursuant to Section 4 of P.L. 1971, c.198 (C), [N.J.S.A.40A:11-4] and publicly opened by the Township Engineer on August 11, 2022; and

WHEREAS, the Borough received five (5) bid proposals from Landberg Construction, LLC (\$375,272.76); Lexa Concrete, LLC (\$384,680.35); Think Paving Hardscaping, LLC (\$380,928.00); Charles Marandino, LLC (\$419,431.30); and Paving Plus, LLC (\$435,937.30*-Corrected Amount) on August 11, 2022; and

WHEREAS, the Engineer has reviewed all Bids and recommended the award of the Base Bid, Alternate #1 and Alternate #2 to Landberg Construction LLC. for a Base Bid sum of \$360,963.01, Alternate #1 in the sum of \$5,961.10 and Alternate #2 in the sum of \$8,348.65 for a total Bid amount of \$375,272.76; and

WHEREAS, the Engineer has also determined that the Bids submitted by Landberg Construction LLC represent the lowest responsible Bid and that the Bidder is qualified to perform the work specified; and

WHEREAS, the bid submitted by the aforesaid Landberg Construction, LLC is in substantial compliance with the bid instructions and specifications generated by the Borough; and

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that the 2021 NJDOT Walnut Avenue Roadway Improvements Project (Phase I) is hereby awarded to Landberg Construction, LLC in the following amount which shall not be exceeded: Bid of \$375,272.76, subject to and conditioned upon the provisions of performance surety and further compliance with the bid documents and specifications by Landberg Construction, LLC including verification of funds by the Borough CFO.

BE IT FURTHER RESOLVED, that the Municipal Clerk is hereby authorized and directed to return all bid surety to all unsuccessful bidders forthwith after the adoption hereof.
