**WHEREAS**, said director may also approve the insertion of any item of appropriation for equal amount,

**NOW, THEREFORE, BE IT RESOLVED** that the Borough of Woodbury Heights, County of Gloucester, hereby requests that the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget year 2022 in the sum of \$35,300.00, which item is now available as a revenue from **Gateway Regional High School Agreement**, and

**BE IT FURTHER RESOLVED** that a like sum of \$35,300.00 be and the same is hereby appropriated under the caption of:

**BE IT FURTHER RESOLVED** that the above is the result of a Shared Service Agreement with Gateway Regional High School for school resource officers.


