

ORDINANCE 8-2023

AN ORDINANCE AMENDING AND SUPPLEMENTING CERTAIN PROVISIONS WITHIN CHAPTER 37 OF THE WOODBURY HEIGHTS CODE ENTITLED “ALCOHOLIC BEVERAGES: PUBLIC CONSUMPTION”

BE IT ORDAINED by the Borough Council of the Borough of Woodbury Heights, that the following Sections within Chapter 37 of the Woodbury Heights Code entitled “Alcoholic Beverages: Public Consumption” are hereby amended and supplemented, to read as follows:

§ 37-6 entitled “Prior Permission Required” is repealed and replaced with the following entitled “Special Permit Exceptions”.

Notwithstanding any other provision under this Chapter, including, but not limited to, the provisions of Section § 37-2, the Mayor and Borough Council of the Borough of Woodbury Heights may for good cause issue a special permit exception for the possession or consumption of alcoholic beverages in public for a specific event or activity and for a specified time and location within any such public park, playground, recreation area or other public place under its jurisdiction. The special permit exception shall only be granted upon submission to the Mayor and Borough Council of the Borough of Woodbury Heights of a request, in writing, for the special permit, setting forth the nature or purpose of the special event; the location of said special event; the date and time(s) of said special event; and the organization sponsoring said special event, which shall include the name of the applicant or some other person(s) on behalf of the applicant who agrees to be present at the event or activity in charge of the same.

§ 37-9 Discarding Alcoholic Beverage Containers. (NEW SECTION)

No person shall discard any alcoholic beverage bottle, can, jar, cup, glass, or other alcoholic beverage vessel upon any public place, street, lane, sidewalk, public parking lot, quasi-public place or upon any private property not his or her own without having the express permission of the owner or any person having authority to grant such permission.

BE IT FURTHER ORDAINED as follows:

1. **Effective Date:** This Ordinance shall take effect _____, 2023 and upon final adoption, publication and as otherwise provided by law.
2. **Repealer:** All Ordinances or parts of Ordinances inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
3. **Saved from Repeal:** All Ordinances or parts of Ordinances not inconsistent with the terms and provisions of this Ordinance are hereby saved from repeal.
