**RESOLUTION OF THE BOROUGH OF WOODBURY HEIGHTS AWARDING
CONTRACT FOR THE REBID OF THE CANDIDUS AVENUE PUMP STATION
REHABILITATION PROJECT**

WHEREAS, the Borough of Woodbury Heights heretofore advertised for the submission of bids relative to the Candidus Avenue Pump Station Project for the Borough; and

WHEREAS, bids for this road project were advertised pursuant to Section 4 of P.L. 1971, c.198 (C), [N.J.S.A.40A:11-4] and publicly opened by the Borough Engineer on February 7, 2023; and

WHEREAS, the Engineer has reviewed all Bids and recommended the award of the Base Bid (Part 1) and Base Bid (Part 2) to B&H Contracting Inc. for a Base Bid (Part 1) sum of \$660,000.00 and Base Bid (Part 2) in the sum of \$66,000.00 for a total Bid amount of \$726,000.00; and

WHEREAS, the Engineer has also determined that the Bids submitted by B&H Contracting Inc. represent the lowest responsible Bid and that the Bidder is qualified to perform the work specified; and

WHEREAS, the bid submitted by the aforesaid B&H Contracting Inc. is in substantial compliance with the bid instructions and specifications generated by the Borough.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that Candidus Avenue Pump Station Project is hereby awarded to B&H Contracting Inc. in the following amount which shall not be exceeded: Bid of \$726,000.00, subject to and conditioned upon the provisions of performance surety and further compliance with the bid documents and specifications by B&H Contracting Inc., including verification of funds by the Borough CFO.


CERTIFICATION OF AVAILABILITY OF FUNDS
