

RESOLUTION 81-2023

**RESOLUTION OF THE BOROUGH OF WOODBURY HEIGHTS AWARDING
CONTRACT FOR WALNUT PHASE II ROADWAY IMPROVEMENTS PROJECT**

WHEREAS, the Borough of Woodbury Heights heretofore advertised for the submission of bids relative to the Walnut Avenue Phase II Roadway Improvements Project for the Borough; and

WHEREAS, bids for this road project were advertised pursuant to Section 4 of P.L. 1971, c.198 (C), [N.J.S.A.40A:11-4] and publicly opened by the Borough Engineer on June 22, 2023; and

WHEREAS, the Engineer has reviewed all Bids and recommended the award of the Base Bid, Alternate No. 1 Bid, Alternate No. 2 Bid and Alternate No. 3 Bid to Landberg Construction LLC. for a Base Bid sum of \$246,283.81, Alternate No. 1 Bid in the sum of \$10,000.00, Alternate No. 2 Bid in the sum of \$34,500.00 and Alternate No. 3 Bid in the sum of \$76,171.45 for a total Bid amount of \$366,955.26; and

WHEREAS, the Engineer has also determined that the Bids submitted by Landberg Construction LLC represent the lowest responsible Bid and that the Bidder is qualified to perform the work specified; and

WHEREAS, the bid submitted by the aforesaid Landberg Construction LLC is in substantial compliance with the bid instructions and specifications generated by the Borough.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Woodbury Heights, with the Mayor concurring, that the Walnut Avenue Phase II Roadway Improvements Project is hereby awarded to Landberg Construction LLC in the following amount which shall not be exceeded: Bid of \$366,955.26, subject to and conditioned upon the provisions of performance surety and further compliance with the bid documents and specifications by Landberg Construction., including verification of funds by the Borough CFO.


CERTIFICATION OF AVAILABILITY OF FUNDS
