RESOLUTION AUTHORIZING CONTRACT FOR COMMUNITY CENTER MULTIPURPOSE ATHLETIC FLOOR UNDER THE TIPS INTERLOCAL PURCHASING SYSTEM

WHEREAS, the Borough of Woodbury Heights needs an upgrade to the floor at the Woodbury Heights Community Center located at 741 Helen Avenue, Woodbury Heights, NJ to a multipurpose athletic floor; and

WHEREAS, Dynamic Sports Construction, Inc is an authorized vendor of multipurpose athletic floors under Tips Co-Op #21090501; and

WHEREAS, the Qualified Purchasing Agent recommends an award of a contract to Dynamic Sports Construction, Inc in the amount of \$103,875.00; and

WHEREAS, the Chief Financial Officer has certified funds in the amount of \$103,875.00 for the contract for installation of said floor together with the preparation of the current floor.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Woodbury Heights, that a contract for the preparation and installation of a multipurpose athletic floor per proposal dated June 12, 2023 from Dynamic Sports Construction under TIPS Co-Op #21090501 is approved subject to the issuance of the appropriate purchase order to Dynamic Sports Construction Inc to be filed through the TIPS Co-Op procedures.
