RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT TO ROBBIE CONLEY ARCHITECT, LLC FOR PRELIMINARY ARCHITECTURAL SERVICES RELATED TO THE CONSTRUCTION OF A NEW PUBLIC WORKS BUILDING

WHEREAS, the Borough of Woodbury Heights has a need to retain architectural services for preliminary design for the construction of a new public works building as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and,

WHEREAS, the Purchasing Agent/CMFO has determined and certified in writing that the value of the services from Robbie Conley Architect, LLC will exceed \$17,500; and,

WHEREAS, the anticipated term of this contract is 1 year(s) and may be extended 2 times as approved by this governing body; and

WHEREAS, Robbie Conley Architect, LLC has submitted a proposal dated October 6, 2023 indicating they will provide schematic design services and design development for the public works building in the amount of \$31,150.00; and

WHEREAS, Robbie Conley Architect, LLC has completed and submitted a Business Entity Disclosure Certification which certifies that Robbie Conley Architect, LLC has not made any reportable contributions to a political or candidate committee in the Borough of Woodbury Heights in the previous one year, and that the contract will prohibit Robbie Conley Architect, LLC from making any reportable contributions through the term of the contract, and

WHEREAS, the Chief Financial Officer has certified funds in the amount of \$31,150.00 for the services to be rendered by Robbie Conley Architect, LLC for the preliminary design work for the development of a public works building.

NOW THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Woodbury Heights authorizes the Mayor to enter into a contract with Robbie Conley Architect, LLC as described herein; and,

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification, the proposal of Robbie Conley Architect, LLC and the Determination of Value be placed on file with this resolution. and,

BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Borough Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that a notice in accordance with the Local Public Contracts Law of the State of New Jersey shall be published in the South Jersey Times.
