**RESOLUTION OF THE BOROUGH OF WOODBURY HEIGHTS AUTHORIZING THE
PERSON-TO-PERSON TRANSFER OF LIQUOR LICENSE FROM HOLLYWOOD
CAFÉ & DINER, INC. TO HOLLYWOOD, LLC**

WHEREAS, an application has been filed for a Person-to-Person Transfer of Plenary Retail Consumption License Number 0823-33-001-008, heretofore issued to Hollywood Café & Diner, Inc for the premises located at 940 Mantua Pike, Woodbury Heights, New Jersey; and

WHEREAS, the application and affidavit of publication submitted with the Borough Clerk is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term; and

WHEREAS, a Tax Clearance Certificate has been received from the Division of Taxation; and

WHEREAS, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey Statutes, regulations promulgated thereunder, as well as pertinent local ordinances and conditions consistent with Title 33; and

1. The Mayor and Borough Council does hereby approve the transfer of the

aforesaid Plenary Retail Consumption License #0823-33-001-08 to Hollywood, LLC and does hereby direct the Borough Clerk to endorse the license certification to the new ownership, as follows: "This license, subject to all its terms and conditions, is hereby transferred to Hollywood, LLC, effective September 20th, 2023".
