

RESOLUTION 6- 2024

RESOLUTION ESTABLISHING REGULAR MEETINGS OF THE MAYOR AND BOROUGH COUNCIL AND RELATING TO NOTICE OF ALL SUCH MEETINGS

WHEREAS, the "Open Public Meetings Act" requires written notice of all meetings of the Mayor and Council be posted in at least one public place designated and mailed, telephoned, telegraphed or hand-delivered to two newspapers designated by Resolution and further requires mailing to all persons requesting a copy of same upon payment of an established fee;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Woodbury Heights, as follows:

1. Notice of all meetings shall be posted by the Clerk on the bulletin board located within the Municipal Building;
2. All advance notices of meetings shall be given to the SOUTH JERSEY TIMES and COURIER POST newspapers;
3. A fee of \$10.00 payable in advance is hereby established as that fee imposed upon persons requesting mailed, written notice of unscheduled meetings of the Mayor and Borough Council;

BE IT FURTHER RESOLVED that regularly scheduled meetings of the Mayor and Borough Council for the calendar year 2024 shall occur on the third Wednesday of each month, except for the month of November 2024, with such meetings to convene at 7:30 P.M., prevailing time, at the Borough Hall, 500 Elm Ave, Woodbury Heights, New Jersey. The November meeting will be conducted on November 26, 2024 at 7:30pm In accordance therewith, the following dates are hereby established as the regular meeting nights of the Mayor and Borough Council for calendar year 2024: (Action May Be Taken)
