

**ORDINANCE 6-2024**

**ORDINANCE ESTABLISHING FEES FOR DUPLICATE TAX BILLS IN THE  
BOROUGH OF WOODBURY HEIGHTS, COUNTY OF GLOUCESTER, STATE OF NEW  
JERSEY**

**BE IT ORDAINED** by the Borough Council of the Borough of Woodbury Heights, County of Gloucester, New Jersey, as follows that Chapter 34 of the Borough of Woodbury Heights title "Taxes" be hereby amended to include the following:

**§ 34-3. Fees for duplicate tax bills**

- A. In accordance with the applicable provisions of N.J.A.C. 5:33-4.8, the Tax Collector of the Borough of Woodbury Heights is hereby authorized to charge the following fees for the preparation of duplicate tax bills:
- a. Five (\$5.00) Dollars for the first duplicate copy; and
  - b. Twenty-Five (\$25.00) Dollars for each additional duplicate copy requested in the same tax year.
- B. The assessment of duplicate bills fees set forth above may, at the discretion of the Tax Collector, be assessed to a mortgagee, servicing organization or property tax processing organization as defined in P.L. 1990, Chapter 69, N.J.S.A. 54:4-64(d) and upon request for said duplicate tax bill made, in writing, to the Tax Collector.

**BE IT FURTHER ORDAINED** as follows:

1. All Ordinances or parts of Ordinance inconsistent with this Ordinance are hereby repealed to the extent of any inconsistency herewith.
2. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason deemed invalid or unconstitutional by a Court of competent jurisdiction, such part or portion shall be deemed a separate, distinct and independent provision and such holdings shall not affect the validity of the remaining portions hereof which are hereby saved from repeal.
3. This Ordinance shall take effect after its adoption, publication and as otherwise required by law.
