Such charge shall be made by resolution duly adopted specifying the purpose and the estimated amount involved and shall clearly indicate the amounts to be charged is for a purpose for which bonds may be issued under Chapter 1, of Title 40A, and

BE IT FURTHER RESOLVED that such charge against the Capital Improvement Fund need not be deemed a part of the cost of any improvement which may be subsequently financed in the manner provided by Chapter 2 of Title 40A, it being the intent of this procedure to provide an orderly method of financing preliminary expenses in those instance where the local unit does not yet wish or has not determined upon the introduction of a bond ordinance.
