RESOLUTION REVISING THE AWARD OF A NON-FAIR AND OPEN CONTRACT TO PURCHASE A GENERATOR FOR THE GLENWOOD STATION

WHEREAS, the Borough of Woodbury Heights adopted Resolution 74-2024 on August 21, 2024 awarding a non-fair and open contract to purchase a generator for the Glenwood Station; and,

WHEREAS, the cost of said generator has increased to \$25,303 from the original quote of \$22,934 from Cooper Electric Supply, which had expired; and,

WHERAS, Cooper Electric Supply located at 315 Cranbury Half Acre Road in Cranberry, NJ remained the lowest quote for said generator at the revised cost of \$25,303.00; and

WHEREAS, the Chief Financial Officer has certified the additional funds in the amount of \$2,369.00 for the purchase of a generator for the Glenwood Station.

NOW THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Woodbury Heights authorizes the Mayor to enter into a contract with Cooper Electric Supply as described herein; and,

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification, the proposal of Cooper Electric Supply and the Determination of Value be placed on file with this resolution. and,

BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Borough Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that a notice in accordance with the Local Public Contracts Law of the State of New Jersey shall be published in the South Jersey Times.
